To: Rock Ridge Paintball Games Inc. (The sponsor)

Assumption of Risk:

I, the undersigned, have contracted the sponsor and wish to play outdoor paintball and/or laser tag games. I recognize and understand that playing outdoor paintball and/or laser tag games (hereinafter called the "Game") involves certain risks. Those risks include, but are not limited to, the risk of injury resulting from possible malfunction of the equipment used in the game and injuries from tripping or falling over obstacles in the designated game playing arenas. In addition, I recognize that the exertion of playing the game could result in injury or death.

Despite these and other risks, and fully understanding such risks, I wish to play the Game and hereby assume the risks of playing the Game. I also hereby hold harmless the "Sponsors" and indemnify them against any or all claims, actions, suits, procedures, costs, expenses (including attorney's fees and expenses), damages and liabilities arising out of, connected with, or resulting from my playing the Game, including without limitation, those resulting from the manufacture, selection, delivery, possession, use or operation of such equipment. I hereby release the Sponsors from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the Sponsors that I am in good health and do not suffer from a heart condition or other ailment which could be exacerbated by the exertion involved in playing the Game, I further certify that I am 18 years of age or older, and/or that I am signing as a guardian for a player who is under the age of 18 but not younger than the age of 10 for paintball games or 6 for laser tag games.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of participating in the "Game", I hereby agree as follows:

- 1. TO WAVE ANY AND ALL CLAIMS that I have or may in the future have against Rock Ridge Paintball Games Inc., their directors, officers, employees, agents and representatives (all of whom are hereinafter collectively referred to as " the Releasees");
2. TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that I may suffer or that my next of kin may suffer as a result of my participation in outdoor paintball and/or laser tag games due to any cause whatsoever, INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES;
3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of, or personal injury to, any third party, resulting from my participation in outdoor paintball and/or laser tag games; and
4. That this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns in the event of my death.

RESPONSIBILITY FOR RULES AND DAMAGE:

In consideration of participating in the "Game", I hereby agree as follows

- 1. That I will obey all playing rules set out by the sponsor. I understand that I may not consume alcoholic beverages on the premises nor will I be permitted to play the game while intoxicated. I understand that by not following the rules of the game, or playing while intoxicated or there is any suspicion of intoxication, I will not be allowed to play and will not receive a refund.
2. That I am responsible for the cost to repair or replace any rented equipment, other equipment, facility structures or grounds as a result of wilful damage, or damage caused by negligence.
